Delta College Standard Mileage Chart

Listed below is the approved standard mileage for each of the cities listed below. This mileage is calculated from the main campus of Delta College to the city listed. The IRS allows for mileage reimbursement under an accountable plan only for driving directly related to work. Commuting between home and work is NOT a qualified business mileage as the IRS considers it to be a personal expense. Commuting occurs when an employee goes from home to a permanent work location, either the employee's office or other principal place of business or another place where the employee has worked or is assigned to work for more than one year. Employees may not mix personal and business use so if an employee stops to do a personal errand, the mileage for the remainder of that trip is not considered qualified. Mileage related to a trip to see a donor, visit another college, attend a conference out of town, meet with a vendor at their place of business, or pick up an item related to a business purpose is qualified mileage. Mileage is paid at the amount of the current IRS rate.
