**SECTION 2 - HAZARDS IDENTIFICATION**

**Classification** : WHMIS information: This product is not a WHMIS controlled product in Canada. It does not meet any of the criteria for a controlled product provided in Part IV of the Controlled Products Regulations (CPR).



**Emergency Overview** : Clear amber liquid. Petroleum odour.  
Fumes from heated product or mists may irritate respiratory tract. May cause mild eye irritation. Prolonged or repeated skin contact may cause drying and irritation.

**Signs and symptoms of short-term (acute) exposure**

*Inhalation* : If product is heated or mists are formed, inhalation may cause irritation to the nose, throat and respiratory tract.

**SECTION 4 - FIRST AID MEASURES**

**Inhalation** : If inhaled, move to fresh air. If breathing has stopped, give artificial respiration. Consult a physician.

- Skin contact** : Remove contaminated clothing. Wash off with soap and plenty of water. If irritation persists, seek prompt medical attention.

## SECTION 5 - FIRE FIGHTING MEASURES

### Fire hazards/conditions of flammability

- : Not flammable under normal conditions of use. However, may ignite if exposed to extreme heat and flame. Product may float, and be re-ignited at the water's surface. Closed containers may rupture if exposed to excess heat or flame due to a build-up of internal pressure. Vapours are heavier than air and collect in confined and low-lying areas.

**Oxidizing properties** : None known.

### Explosion data: Sensitivity to mechanical impact / static discharge

- : Not expected to be sensitive to mechanical impact or static discharge.

**Suitable extinguishing media** : Dry chemical, foam, carbon dioxide and water fog. Do not use water jet, as this may spread burning material.

### Special fire-fighting procedures/equipment

- : Firefighters should wear proper protective equipment and self-contained breathing apparatus with full face piece operated in positive pressure mode. Move containers from fire area if safe to do so. Water spray may be useful in cooling equipment exposed to heat and flame.

### Hazardous combustion products

- : Carbon oxides; Phosphorus compounds; nitrogen oxides (NOx); Polycyclic aromatic hydrocarbons; Sulphur oxides; other unidentified organic compounds.

## SECTION 6 - ACCIDENTAL RELEASE MEASURES

**Personal precautions** : All persons dealing with the clean-up should wear the appropriate chemically protective equipment. Keep all other personnel upwind and away from the spill/release. Restrict access to area until completion of clean-up. Refer to protective measures listed in sections 7 and 8.

**Environmental precautions** : Ensure spilled product does not enter drains, sewers, waterways, or confined spaces. For large spills, dike the area to prevent spreading.

**Spill response/cleanup** : Ventilate area of release. Remove all sources of ignition. Contain and absorb spilled liquid with non-combustible, inert absorbent material (e.g. sand), then place absorbent material into a container for later disposal (see Section 13). Notify the appropriate authorities as required.

**Prohibited materials** : Do not use combustible absorbents, such as sawdust.

## SECTION 7 - HANDLING AND STORAGE

**Safe Handling procedures** : Use with adequate ventilation. Wear suitable protective equipment during handling. Avoid breathing vapours. Avoid contact with skin, eyes and clothing. Keep away from extreme heat and flame. Avoid contact with incompatible materials. Wash thoroughly after handling. Keep container tightly closed when not in use.

**Storage requirements** : Store in a cool, dry, well-ventilated area. Storage area should be clearly identified, clear of obstruction and accessible only to trained and authorized personnel. Inspect periodically for damage or leaks.

**Incompatible materials** : Strong oxidizing agents.

**Special packaging materials** : Always keep in containers made of the same materials as the supply container.
