SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Skin and serious eye damage, corrosion or irritation (Category 2, 2A). Causes skin and serious eye irritation (H315+H319).



Hazard class: Specific target organ toxicity, single exposure; respiratory tract irritation (Category 3). May cause respiratory irritation (H335).

SECTION 4 — FIRST AID MEASURES

Get medical advice or attention (P313). **If inhaled:** Remove victim to fresh air and keep at rest in a position comfortable for breathing (P304+P340). **If in eyes:** Rinse cautiously with water for several minutes. Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfites, thiosulfates and phosphates.

Store in a cool, dry place.

Wear protective gloves, protective clothing, and eye protection (P280). Wash hands thoroughly after handling (P264).

Possible violent reaction with magnesium. Long exposure to air causes loss of ammonia (NH₃).

Avoid contact with strong oxidizers, NaOCl, and acids. When heated to decomposition, emits toxic fumes of NO_x and NH₃.
