SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Skin corrosion or irritation (Category 1). Causes severe skin burns and eye damage (H314). Do not breathe mist, vapors or spray (P260).

SECTION 4 — FIRST AID MEASURES

Continue rinsing (P305+P351+P338). **If on skin:** Immediately remove all contaminated clothing. Rinse skin with water (P303+P361+P353). Wash contaminated clothing before reuse (P363).

If swallowed: Rinse mouth. Do NOT induce vomiting (P301+P330+P331).
